CHAPTER 130: GENERAL PROVISIONS

130.01 Disturbing the peace

§ 130.01 DISTURBING THE PEACE.

Any person who, within the boundaries of the town, shall unnecessarily make any loud and unusual noise or clamor, or commit any unseemly boisterous conduct, to the disturbance of the peace and quiet of the town shall be deemed guilty of disorderly and unlawful conduct.

§ 130.99 PENALTY.

- (A) Any person violating any provision of this chapter for which no specific penalty is prescribed shall be subject to § 10.99.
- (B) Whoever violates § 130.01 shall be fined not less than \$50, nor more than \$100. For violation of § 130.01, a separate offense shall be deemed committed each time the offender makes a loud and unusual noise or clamor, or commits any unseemly boisterous conduct. (Ord. 4-2003, passed -2003)

FIREARMS ON TOWN PROPERTY

§ 131.01 PROHIBITION.

- (A) No person shall carry a concealed firearm in or on any property, park, building or portion of a building now or hereafter owned, leased as lessee, operated, occupied, managed or controlled by the town, as well as the appurtenant premises to the buildings, upon which appropriate signage has been placed indicating that concealed firearms are prohibited therein.
- (B) It is declared unlawful for any person to fire any gun or pistol within the boundaries of the town; provided that, this provision shall not be construed to extend to the Town Marshal, Deputy Marshal or any police officer while in the performance of his or her duties under state law. § 131.02 SIGNS REQUIRED.

- (A) Signs shall be visibly posted on the exterior of each entrance by which the general public can access the building, appurtenant premises or park.
- (B) The town shall exercise discretion in determining the necessity and appropriate location for other signs posted on the interior of the building, appurtenant premises or park.

§ 131.03 EXEMPTIONS.

- (A) The prohibitions set forth in this subchapter shall not apply to persons who are exempt from concealed weapons prohibitions under state or federal law or to any duly authorized local, state or federal law enforcement officer while on duty.
- (B) The prohibitions set forth in this subchapter shall not apply to highways or public highways owned or administered by the town.

§ 131.99 PENALTY.

- (A) Any person violating any provision of this chapter for which no specific penalty is prescribed shall be subject to § 10.99.
- (B) Whoever violates § 131.01(B) shall be fined not less than \$50, nor more than \$100. For violation of § 131.01(B), a separate offense shall be deemed committed each time a gun or pistol is fired. (Ord. 3-2003, passed -2003)
